Minimum 2(two) years teaching experience in that language at Senior Secondary level in a School / College / Institution / University of Central / State government or Union Territory or Autonomous /Statutory body or Public Sector Undertaking.

5. **Job profile:**

On an average, 50 to 60 language classes of 40-50 minutes of duration each class shall be conducted by Class Room / Online teaching by the Language Instructor in phase-I training of IPS Probationers in Sardar Vallabhbhai Patel National Police Academy, Shivrampalli, Hyderabad.
