About the EFL University

The English and Foreign Languages University (EFLU) (formerly, the Central Institute of English and Foreign Languages [CIEFL] founded in 1958) was created by an Act of Parliament and came into being on 03 August 2007. The EFL University has three campuses: the headquarter is in Hyderabad, while the other two are in Lucknow(since 1979) and Shillong (since 1973).

The University continues to build upon the achievements of the CIEFL, and expand its activities on the national and global stage. Its mandate is to advance and disseminate "instructional, research, and extension facilities in the teaching of English and Foreign Languages and Literatures in India" as well as "to take appropriate measures for inter-disciplinary studies and research in Literary and Cultural Studies, and to develop critical inter-cultural understanding of civilizations," as mentioned in the Act (2006) (No.7 of 2007). The objectives of the University are to bring quality education in the disciplines and sub-disciplines of English and foreign languages within the reach of all Indian and international students.

4-Year BA (Hons/Research) English Programme

The 4-Year BA (Hons/Research)English Programme draws upon the three major disciplinary streams of the University, namely English Language Education, Literary Studies, and Language Sciences, and from the broad spectrum of disciplines in the humanities and social sciences. The Programme has four exit points. Students exiting the Programme at the end of the first year will receive a Certificate, the second year, a Diploma, and the third year, a BA degree. Students who wish to continueon the Programme into the fourth year can opt for a BA (Honors) degree. Those students with a high OGPA can pursue the into the fourth year to obtain a BA (Research) degree.

The envisaged **Programme Outcomes** are as follows. Upon successful completion of the Programme, participants will be able to:

- 1. demonstrate (i) a systematic, extensive, and coherent knowledge and understanding of English Language, the linguistic system and usage, and Literature as a whole and its applications, and affinities to disciplinary areas/subjects of study; including a critical understanding of the established theories, principles, and concepts, and of a number of advanced and emerging issues in English Language and Literary Studies; (ii) knowledge of the English language and culture that creates different types of professionals related to these competencies, including research and development, teaching, and government and public service; and (iii) critical understanding of current developments in English language and literature, and an ability to use established techniques of analysis and enquiry within the humanities in general and English Language study, and Literary Studies in particular;
- 2. demonstrate a broad understanding of the materials, including current research, scholarly and/or professional literature, relating to essential and advanced learning areas pertaining to English Language and Literary Studies, and techniques and skills required for identifying problems and issues relating to the study of the English Language, and the Literatures in English;
- 3. demonstrate skills in collection of relevant quantitative and/or qualitative data drawing on a wide range of sources, analysis, and interpretation of data using methodologies appropriate to the humanities, and for formulating logical and evidence-based solutions and arguments;
- use knowledge, understanding, and skills for critical assessment of a wide range of ideas and complex problems and issues relating to the use of the English Language and the study of Literatures in English and in other cultures;
- 5. communicate the results of studies undertaken in the humanities and language and Literary Studies accurately in a range of contexts using the main paradigm, concepts, constructs, and techniques within the disciplines;
- identify and address one's own learning needs relating to current and emerging areas of study, making use of research, development, and professional materials, including those related to new frontiers of knowledge in the humanities;

- 7. apply one's knowledge of the humanities, English Studies in particular, and transferable skills to new/unfamiliar contexts, and to identify and analyze problems and issues, and seek solutions to real-life problems; and
- 8. demonstrate language and literary competencies and transferable skills that are relevant to some of the job trades and professions.

BA (Hons./Research) Performance Arts and Humanities

The programme introduces students to performing arts from traditional to experimental forms to the students. Courses for eight semesters are about the introduction to performing arts; canonical and experimental drama; historiography of theatre; archeology of theatre; performing techniques; concepts and methods of acting, direction and production; possibilities of forging of body, space and technology in performances; and other related areas/topics. The courses aim at strengthening the conceptual, theoretical and performative aspects of the discipline among students. It stresses on the training and disciplining of students in artforms of their choice within the field of Performing arts and Humanities. In the third year of the programme, students will be encouraged to undertake research projects and internships with performance related industry to explore the innovative dimensions in the area, experiment with the available means and technologies, and generate scholarship in the domain area. Students exiting the Programme at the end of the first year will receive an Undergraduate Certificate, the second year, an Undergraduate Diploma, and the third year, a BA degree. Students who wish to continue on the Programme into the fourth year can opt for a BA (Honors) degree. Those students with a high OGPA can pursue the Programme to obtain a BA (Research) degree.

The Programme Outcomes are as follows:

At the end of the Programme the students will be able to:

- 1. demonstrate (i) a systematic, extensive and coherent knowledge and understanding ofperformance arts and affinities to disciplinary areas/subjects of study; including a critical understanding of the established theories, principles and concepts, and of a number of advanced and emerging issues in performance and theatre studies; (ii) explore possibilities of engagements between performance, theatre and new media; (iii) knowledge of the performance arts that creates different types of professionals related to these competencies, including actors-performers, directors, script writers, set and costume designers, and a critical understanding of the present forms of theatre arts, practices and theories
- 2. demonstrate a broad understanding of the study materials, research materials as well as documents of performances in various media and abilities to find problems and solutions through the innovative approaches in performance arts
- 3. use knowledge, understanding, and skills for critical assessment of a wide range of ideas and complex problems and issues relating to the performance arts in Indian and world theatre
- 4. demonstrate competencies and skills acquired through the training in performance arts that are relevant to performance related occupations such as performers, script writers, directors, set designers, and other related professions.

B.A. Dissertation Guidelines

Students of B.A. Research are required to write a dissertation on a research topic of their choice, under the supervision of a faculty member. The dissertation is worth 10 credits and intends to provide students with an introduction to independent research. The topic chosen should be directly from the domain the student is majoring in. The dissertation could be on theory or on application of a theory. The dissertation should have a modest focus so that it can be completed within a semester.

- 1. Format guidelines:
 - Length: 10,000 12,000 words (approximately 25-30 pages)
 - Paper size: A4, Spacing: double space, Font type: Times New Roman, Font size: 12
 - The Dissertation should have the following parts/sections:

- 2. Plagiarism clearance: The project should be checked for plagiarism by the Supervisor before submission (Please use Turnitin for this purpose.) The University allows up to10% similarities. All sources cited in the body of the dissertation must be acknowledged.
- 3. Choosing a Supervisor: Students can choose a Supervisor based on the topic of their choice and the teacher's willingness to guide the student. A completed dissertation form with a tentative title has to be submitted in the Office of the Controller of Examinations by the deadline mentioned during course registration.
- 4. Meeting the Supervisor and attendance: Since the dissertation is equivalent to a taught course on the programme, students have to meet their Supervisors for at least 4 hours a week. The attendance sheet, duly signed by the Supervisor, has to be submitted at the end of every month in the Office of the Controller of Examinations (attendance sheets are available in the Office of the Controller of Examinations).
- 5. Submission and evaluation: Two hard-bound copies of the completed dissertation have to be submitted in the Office of the Controller of Examinations. It will be evaluated by the Supervisor and one external examiner, chosen by the department concerned, who is familiar with the area of work. A final grade arrived at by these two examiners will be submitted in the Office of the Controller of Examinations.

Attendance requirement

Students are required to attend all lectures, tutorials, language laboratory sessions, etc. A student shall be deemed to have pursued a regular course of study provided that he/she has attended at least 75% of the classes held in each course and has completed all class/periodical/continuous assessment/sessional tests, assignments, and practicals as prescribed by the School(s)/Department(s)/Programme Committee(s) concerned.

Please note as per University rules

Students who do not fulfill the attendance requirement are not eligible to appear for the semester-end examination.

Relaxation in attendance

- i. The 75% attendance requirement maybe relaxed by 5% for those who participate in extra-curricular activities with the **prior permission** of the authorities concerned.
- ii. The 75% attendance requirement may be relaxed by 10% on medical grounds.
- iii. Further to these concessions, the Vice-Chancellor, on the recommendation of the Dean(s)/Head(s) of the Department(s)/Programme Coordinator(s), may condone the shortage in attendance not exceeding 10% for valid and convincing reasons.

Absence due to authorized participation in sports activities (at national, state and university levels) will not be treated as shortfall in attendance.

Notwithstanding any of the above, the attendance requirement may not in any case be relaxed below 60%.

Evaluation

The performance of a student on a programme will be on the basis of

- (i) continuous assessments, and
- (ii) semester-end examinations.

The ratio of continuous assessment to semester-end examinations will be 40:60.

Continuous assessment may comprise class tests, assignments, presentations, or response papers. There will be a minimum of three continuous assessment tests. The best two of three will be considered for the final grade.

Semester-end assessment may be in the form of a sit-down, open-book, or takehome examination, or a term paper. The type of assessment for a particular course/programme will be declared by the tutor or programme coordinator at the beginning of the course/programme. For all programmes, the credit system is employed. For evaluating a student's performance, the following 8-point grading scale will be used:

Formula for calculation of OGPA:

Grade point for Course 1 + Grade point for Course 2 + Grade point for course 3 + ---Number of Courses

Formula for conversion to percentage: $\frac{\text{OGPA}}{9}$ x100

For example, if OGPA is 9, percentage will be: $\frac{9}{9}$ x 100 = 100%;

if OGPA is 3.6, percentage will be: $\frac{3.6}{9}$ x 100 = 40%;

if OGPA is 4.95, percentage will be: $\frac{4.95}{9}$ x 100 = 55%

Promotion to the next Semester, Credit transfer, Credit Accrual and Credit Redemption

- i. For promotion to the next semester, a student should not have a backlog of more than two Courses/papers at any given semester.
- ii. Students can obtain a certificate, diploma, or a degree from the University after the successful completion of each semester of a programme that they have enrolled for. The qualification (UG Certificate/ UG Diploma/Degree) will depend on the number of semesters they have successfully completed, when they choose to exit the programme.
- iii. The EFL University offers students the facility to bank your credits. The Academic Bank of Credits (ABC), linked to the National Academic Depository (NAD), where the academic and other data of students are stored, enables students to register or commence credit transfer. However, the University is responsible for the final outcomes of credit redemption and issuance of certificates, as well as the compilation of award records. These will be administered via the NAD Platform.
- iv. Credits earned and deposited with ABC shall be valid for the purpose of redemption to a degree or diploma or Post Graduate diploma or certificate, to a maximum duration of seven years.
- v. Credits obtained by undertaking Courses from the academic year 2021-2022 onwards are eligible for Credit transfer, Credit accrual and Credit redemption through Academic Bank of Credits.
- vi. To obtain a degree from the English and Foreign Languages University, students are required to earn a minimum of fifty per cent of the credits from the University.

(The University Grants Commission (Establishment and Operation of Academic Bank of Credits in Higher Education) Regulation, 2021)

Supplementary/Grade Improvement Examination

Students who obtain grade **B** or below and are desirous of improving their grades in any module/course may take a Grade Improvement/ Repeat Examination.

Supplementary examinations shall serve as repeat examinations. Supplementary examinations shall be scheduled around the second or third week of January (2nd, 4th, 6th, and 8th semesters) and July (1st, 3rd, and 5th semesters) in Hyderabad and Lucknow campuses and in the last week of February (for 2nd, 4th, and 6th semesters) and second and third week of June (for 1st, 3rd, and 5th semesters) in the Shillong campus.

Only those students who fulfill the attendance, discipline, and academic requirements of the programme shall be allowed to exercise the option of Supplementary/Grade Improvement/Repeat examination.

Students are required to apply to the Controller of Examinations through the Chairperson, BoS, concerned within seven days of commencement of the following semester or declaration of results whichever is later for Grade Improvement/Repeat

examination paying a fee of Rs.120/- subject to revision from time to time for each paper.

Rules of Disciplineand Proper Conduct

The rules listed here shall apply to all students of the University under Article 29 of the Statutes of the EFL University. Any breach of discipline and conduct committed by a student inside or outside the EFL University Campus shall fall under the purview of these rules.

Categories of misconduct and indiscipline

- All acts of violence and forms of coercion such as gheraos, dharnas, sit-ins which disrupt the normal academic and administrative functioning of the University
- Sexual harassment
- Committing forgery, defacing/destroying/damaging books/journals of the library, etc.
- Furnishing false certificates or false information
- Eve-teasing or disrespectful behavior with a girl student
- Arousing communal, caste or regional feelings or disharmony among students
- Use of abusive, defamatory, derogatory language
- Pasting of posters of an objectionable nature
- Unauthorized occupation of the hostel room/s
- Indulging in acts of gambling
- Use of the title of the University when distributing any document other than academic work outside the University
- Consuming or possessing dangerous drugs
- Non-payment of fees and other dues including mess charges
- Ragging in any form
- Refusal to obey the directions of the officers of the University
- Unauthorized collection of funds for any student's programme
- Any other act which may be considered by the Competent Authority as a violation of discipline, or misconduct

Punishments

The Competent Authority may impose punishment on any student found guilty of any of the acts of indiscipline or misconduct mentioned above.

Anti-Ragging Committee

Any form of ragging within the premises of the EFL University will be viewed seriously and dealt with swiftly and severely by the Administration (vide Ordinance 6.2, entitled "Prohibition of and Punishment for Ragging," of the English and Foreign Languages University.) Anti-ragging squads and an Anti-Ragging Committee will be empowered to take *suo moto* action or upon receiving a complaint. As per the directions of the Supreme Court of India, "if any incident of ragging comes to the notice of the authority, the concerned students hall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the University."

Anti-Sexual Harassment and Redressal Mechanism

The EFL University has evolved a policy against sexual harassment to create for women students on its Campuses a gender-just and secure environment (vide Ordinance 7.2, Annexure-I, entitled "Sexual Harassment", of the English and Foreign Languages University). Every Campus of the EFL University has a Complaints Committee, with representatives from all sections of the University, to address the complaints of women students and staff.

The names, addresses and phone numbers of the members of University Complaints Committee (UCC) are displayed in all prominent places in the Campus.

The complaints will be kept confidential and the Committee has the power to recommend any action(s) against the perpetrators. The Committee also takes upon itself the task of organizing various gender sensitization programmes. There is also an Appellate Committee to consider problems when the Complaints Committee's decisions are not found satisfactory.

Removal of Students from the Courses

The Dean of the School/Proctor / Dean, Student's Welfare / the Dean (Research) may recommend to the Vice Chancellor the removal of a student from a Programme/Course on the basis of unsatisfactory academic performance and / or misconduct (as defined in the Regulations) / or non-payment of fees on time.

Grievance Redressal Mechanism

All grievances within the University will be resolved through discussions and negotiations and through a Grievance-Redressal mechanism. The following are some of these:

- Grievances with regard to the Hostels may be referred to the Provost/Warden concerned
- **Individual grievances** may be referred to teachers in each Department who will be appointed staff advisers.

- **Group grievances** may be resolved within the Department.
- **Miscellaneous grievances** pertaining to Library/Finance/Sports, etc. will be resolved by the Committee concerned.
- Academic grievances of students: Students aggrieved due to the grade awarded in a course may apply in a prescribed form along with a fee of Rs. 100/- for each course to the Head of the Department giving reasons for his/her feeling aggrieved within one month of the notification of the results. A Committee will examine the case and the grade awarded by the Committee upon review will be final. All grievances should be submitted to the appropriate body within two weeks after the event at issue.
