#### Assignment I (Based on Block I and Block II)

- I. In Blocks I and II, you learned about English Renaissance drama, considered the crowning literary achievement of the Elizabethan Age. Now, answer the following questions.
  - 1. What factors led to the growth and popularity of this literary form?

- 2. Explain the significant developments in the theatre and stage during the Elizabethan Age. (500 words)
- 3. What were the popular themes in English drama of the Renaissance period? (500-700 words)
- II. Describe the Shakespearean genres and explain how they depart from the formulaic conventions of drama of the Early Modern Age. (750 words)

- III. Elucidate Jonson's use of animal imagery in *Volpone*, *or the Fox*. On the basis of this imagery can the play be considered an animal fable conveying a simple moral? Explain. (around 1000 words)
- IV. You have studied two revenge tragedies in Block I: *The Spanish Tragedy* and *The Duchess of Malfi*. Now, answer the following:
  - 1. What do you understand by the term 'revenge tragedy'? What are its characteristic features? Explain with reference to the two plays in the genre that you have studied. (800-1000 words)
  - 2. How would you account for the popularity of the theme of personal vengeance for the English audience of this age? (500 words)
  - 3. Compare the portrayal of the two women protagonists of the two plays with regard to the theme of agency. (800-1000 words)
- V. Explain how Shakespeare's *Henry V* develops and reinforces a sense of English identity. (around 1000 words)
- VI. Read the following extract, identify the play (along with the Act and Scene) it is taken from, and explain the context. Also explain the extract in terms of the important theme that it highlights.
